#### **Warranty Statement**

## **Battery Warranties**

Battery will maintain no less than 80% rated capacity for a 12 month period from date of purchase from Axess International.

Battery will maintain no less than 80% rated capacity for a 12 month period from date of purchase from Axess International.

### **Rechargeable Lead Acid Batteries**

Battery will maintain no less than 80% rated capacity for a 6 month period from date of purchase from Axess International.

#### Non-Rechargeable Single & Primary Cells

Battery will perform at 100% rated capacity upon delivery from Axess International.

#### **Cellular Batteries & Accessories**

All cellular accessories will function under normal working conditions for a 6 month period from date of purchase from Axess International.
